### **Revisionsberättelse för år 2023**

Jag har granskat räkenskaperna, årsredovisningen och förbundsstyrelsens förvaltning i Fryksdalens Samordningsförbund (organisationsnummer 222000-2550) för verksamhetsåret 2023.

Mitt uppdrag är att pröva om verksamheten sköts på ett ändamålsenligt och från ekonomisk synpunkt tillfredställande sätt, om räkenskaperna är rättvisande och om den interna kontrollen är tillräcklig.

Förbundsstyrelsen ansvarar för att verksamheten bedrivs enligt gällande mål, beslut och riktlinjer samt de lagar och föreskrifter som gäller för verksamheten. Styrelsen upprättar en årsredovisning som ger en rättvisande bild samt svarar för att det finns en tillräcklig intern kontroll i verksamhet och räkenskaper.


**Jag bedömer** sammantaget att resultatet enligt årsredovisningen är förenligt med de finansiella mål och verksamhetsmål som är uppställda.

## **ELECTRONIC RECORD AND SIGNATURE DISCLOSURE**

From time to time, KPMG AB (we, us or Company) may be required by law to provide to you certain written notices or disclosures.
